- A. Prerequisite: An instructor interview with analysis of past academic success.
- B. 3 semester hours credit
- C. Model United Nations emphasizes the origins, structure, and functions of the United Nations in the contemporary international arena. Model United Nations is an independent study course, running from October to February, which includes participation in the Midwest Model United Nations, where students will represent a country in a simulation.
