Program Description: The Law Enforcement Academy incorporates both Associate of Applied Science degree in Law Enforcement and the Missouri Department of Public Safety Peace Officer Standards and Training (POST) Class A License curriculum. This fast-paced program offers both academic and practical exercises to prepare the participant for a career in law enforcement. In addition to the academic class curriculum, the training also includes OC pepper spray, expandable baton, breathalyzer operator permit, first aid/CPR/AED, Taser certification, defense tactics, and fitness training.

Admission Requirements: Successfully complete College application and placement tests. A separate Law Enforcement Academy application is also required. The application process to the Law Enforcement Academy is a competitive process that includes the academy application, a physical fitness agility assessment, and interview.

Jefferson College Program Highlights:

- The Law Enforcement Academy is accredited through the Commission on Accreditation for Law Enforcement Agencies (CALEA) / Academies.
- The Law Enforcement Academy is licensed by the Missouri Department of Public Safety – Peace Officer Standards and Training Commission (MO DPS POST).
- The Law Enforcement Academy training includes state-of-the art VirTra firearms training simulator; DORON driver training system; handguns/shotguns/patrol rifles and ammunition; vehicles; and multiple mock training scenario rooms.
- The program requires all students complete ride-along and community service hours outside the schedule class hours. These opportunities help to identify job prospects and enhance hire rates.
- The program has a 100% pass rate for the MO DPS POST Class A License test required for commissioned personnel.

Transfer Information:

The Associate of Applied Science degree in Law Enforcement will generally not transfer to four-year institutions. Exceptions may be made if transferring to a four-year Criminal Justice Program or to one of the institutions that has an articulation agreement in place with Jefferson College. General education courses taken within the Law Enforcement Academy degree plan will transfer to four-year institutions.
