The Philosophy program at Jefferson College strongly supports the Mission of the College. In the Mission the College affirms its support of "Superior teaching [...] which promotes intellectual, social, and personal growth." Philosophy is uniquely positioned to serve this mission by providing students with the tools to

- Reflect upon their own values and place in the world
- Develop critical thinking skills which are needed for worthwhile self-directed thought
- Develop an awareness of the intellectual traditions which shape their world
- Experience patterns of thought alien to their own, and
- Engage actively with the world of ideas.

The Philosophy program is academically rigorous and content-rich. Its offerings transfer to a wide variety of institutions and programs and directly support the goals of Student Academic Success and Ethical Behavior.

Since the 2006 Program Review, the Philosophy Program has experienced the following accomplishments:

- A new course, PHL 102H, Honors Introduction to Philosophy, has been offered for the first time In the Spring Semester of 2011.
- A night course of PHL 202H, Honors Ethics, was one of the first Honors classes offered at the Arnold site in the Fall of 2006.
- The Philosophy Program hosted a panel discussion on Health Care Reform during the Fall Semester of 2009 which was open to the public and telecast by JCTV.
- Dr. Booker's Logic text, *The Way of Reason*, was accepted for publication by National Social Science Press and will be available nation-wide in the Spring of 2012.

- The *Way of Reason* is sold to our students through the bookstore at a significantly reduced cost, resulting in an approximate total textbook cost savings \$100,000.00 to Logic students since 2003.
- Dr. Booker appeared as a speaker at the College's Friday Speaker Series in the Fall of 2010 and spoke about his experiences while training with NATO in Germany.
- In order to save students money, a course packet for the Ethics course has been prepared which covers the same core material as published texts while making appropriate (ethical) use of intellectual property and obtaining permissions for all materials being reprinted.
- Dr. Booker served a key role in the preparation of the HLC (Higher Learning Commission) Self-Study which permitted Jefferson College to receive the highest possible (ten year) reaccreditation.

As the program makes extensive use of in-house published materials (for the Ethics course and for the Logic course), student feedback has been instrumental in refining and revising the content of both course packets. When students find material challenging, faculty have the luxury of being able to enhance the material in the course packets to support their academic success.

#### **Program Offerings, Enrollment and Attrition Trends**

1. Philosophy courses are offered at Hillsboro, JCA, JCNW, and online. Introduction to Philosophy and Ethics are offered as honors courses. Philosophy courses are offered fall, spring, and summer; days and evenings on-campus; and in first eight-week and second eight-week formats. The online Medical Ethics classes are popular with students majoring in the health-care professions, many of whom live outside our college district.

The following courses are offered by the program:


PHL101 Logic
PHL102 Introduction to Philosophy
PHL102H Honors Introduction to Philosophy
PHL201 World Religions
PHL202 Ethics
PHL202H Honors Ethics
PHL203 Medical Ethics

All philosophy courses transfer to four-year institutions as humanities and general education credit.

2. Philosophy is a very cost-efficient and popular program. With one full-time faculty member and an average of four adjunct faculty, the program generates approximately 2,500 credit hours per year with class sections that generally fill at 32 seats per class.

3. The Philosophy program has experienced a relatively steady increase in enrollment since the last program review, with an overall 8% increase since 2006-2007, despite a 9% decrease in 2009-2010 from the previous year. The 2009-2010 enrollment decrease is attributed to fewer sections being offered during the summer, which was rectified the subsequent summer.



4. Course attrition is low at 8.1% overall and 6.6% for full-time faculty. The overall attrition rate includes high attrition rates (14.3%-30%) for ineffective adjunct faculty no longer employed by the division. (Note: second eight-week courses generally have higher attrition rates.) The attrition rate for full-time faculty includes several online course sections per semester. Given these two conditions, the attrition for the program is particularly low.



Analysis

Over the past 5 years, the program has had an average yearly cost per FTE of \$1505.70, with slight increases over that amount in 2007-2008 (due to full-time faculty raises and increased number of adjunct-taught sections) and 2009-2010 (due to enrollment decrease).
